COVID-19 - CECA SCOTLAND UPDATE

Improvements to the Coronavirus Business Interruption Scheme

Following lobbying by CECA and other industry bodies, the Coronavirus Business Interruption Scheme is being extended and improved to increase the number of businesses who can access the scheme.

- Lenders will now be banned from requesting personal guarantees on loans under £250,000.
- Scheme extended to all viable small businesses affected by COVID-19, and not just those unable to secure regular commercial financing
- A new scheme for larger companies (with turnover between £45 million and £500 million) will be introduced to increase support for larger firms not currently eligible for loans
- Chancellor emphasises importance of banks moving quickly to support the economy, jobs and businesses

Scottish Planning System and COVID-19

The Scottish planning system is changing temporarily in response to COVID-19. Changes and new procedures outlined in a <u>letter</u> from Kevin Stewart MSP, Minister for Local Government, Housing and Planning include suspending the need for pre-application consultation on major and national developments to include at least one public event and extending the duration of all planning permissions for a period of 12 months.
