Updated Scottish Government Guidance for Business on Social Distancing

On 4th April, the Scottish Government updated its guidance for businesses on social distancing to help provide clarity on protecting employees in the fight against coronavirus. The revised guidance asks all business workplaces not specifically required to close to consider **two key questions** and at all times work on a precautionary basis:

- Is what you do essential or material to the effort against the virus or to the well-being of society?
- Are you able to demonstrate and give confidence to your workforce that you can consistently
 practice safe social distancing and comply with ALL other standard health and safety
 requirements?

If the answer to either of the above questions is no, the advice is to close. The Scottish Government make clear also that <u>updated guidance</u> published today (6th April) by the UK Government <u>"does not apply in Scotland"</u>. Until such time as further guidance is issued making clear what work activity can be undertaken safely, in a way that is fully compliant with social distancing, the Scottish Government have again repeated their guidance that *"non-essential workplaces, including construction sites, should close."*

Coronavirus Job Retention Scheme

Over the weekend, the UK Government published an update to its <u>employer guidance</u> and <u>guidance</u> for <u>employees</u> on the Coronavirus Job Retention Scheme. The updates provide more detailed

information on scheme eligibility, further details of how to calculate a claim and clarification on what constitutes wages.

MacRoberts LLP have provided a useful briefing which you can read here. In summary, it confirms:

- Apprentices can be furloughed along with other employees.
- Employees who stopped working for an employer on or after 28 February 2020 can be reemployed by them and put on Furlough Leave.
- Employees who are unable to work because they have caring responsibilities as a result of COVID-19 can be furloughed.
- Office Holders and Company Directors can be furloughed.
