# **Industry Engagement with Scottish Government**

CECA Scotland has been actively engaged in discussions with the Scottish Government to set the priorities and actions for recovery based on industry concerns, with work focussed on Safe Operating Procedures and Industry Restart. These meetings are chaired by Kevin Stewart MSP, Minister for Local Government, Housing and Planning. The third full meeting of the Construction Scotland/Scottish Government Leadership Forum, focused on COVID-19 Recovery Planning, took place on 5<sup>th</sup> May and a full report has been circulated to our distribution list today (6<sup>th</sup> May).

Thanks to all CECA Scotland members who have been in touch to share your views. We will continue to ensure these are represented at the highest level, to share your examples of best practices and to keep CECA members fully updated on discussions as they continue to progress.

# CSIC Online Workshop: Innovation in construction training and practice

## Update on the Self-Employment Income Support Scheme

Whilst this information will not of be of primary concern for CECA companies, we are aware that many members distribute our Daily Update across their supply chain to keep them informed and up to date. The information below will be important to all of the self-employed people in your respective supply chains.

The UK Government has confirmed that the scheme will now be delivered ahead of the original June schedule - with individuals able to apply for the grant from 13 May. HMRC will begin contacting eligible self-employed individuals this week by email, text and letter to inform them that they are eligible and explain what they need to do to apply. Applications will open in tranches using the Unique Tax Reference (UTR) number given to all self-employed taxpayers.

To provide further support to the claims process, the Treasury have launched an online eligibility checker tool available <u>here</u>. This will also provide eligible self-employed individuals with a confirmed date from 13 May from which they will be able to apply for their grant.

- It provides detail on how individuals or their business can be "adversely affected" by COVID-19, to claim the grant.
- It clarifies that if individuals have taken parental leave at any point between the end of 2018-19 and now, they can still claim the SEISS, as parental leave is not considered a break in trading.
- It states that the grant provides three months' worth of support, but it is not tied to a specific time period and confirms that the grant is capped at £7,500.
- It explains how the eligibility criteria applies the 50% rule. The guidance now compares your trading profits to your non-trading income.
- It clarifies that, for the purposes of calculating non-trading income, the only social security benefits used are the *taxable* benefits.
- It sets out the position on late tax returns, tax returns under enquiry and amended tax returns.
- It sets out the information that individuals will need to provide when they make their claim.
- It sets out the records that individuals will need to maintain after claiming the grant.

A reminder that if you are not eligible for the UK Government scheme, you may be eligible for the Scottish Government's <u>Newly Self-Employed Hardship Fund</u>.

# Small Business Grant Scheme

The second phase of the Small Business Grant scheme - which extends grant support to all subsequent eligible properties - is now open for applications, Finance Secretary Kate Forbes announced yesterday. The second phase of the Small Business Grant scheme ensures that - in addition to existing grants of £10,000 or £25,000 for the first property - businesses may now qualify for grants of £7,500 or £18,750 on all subsequent eligible premises.
