Project bank accounts signing requirements during COVID-19 CPN 2/2020

The Scottish Government have today (14th April) issued a Construction Policy Note which allows Project Bank Accounts to be signed off by electronic signature until at least June 30th. Read more <u>here</u>.

HSE Joint Statement with the Partnership for Health & Safety in Scotland (PHASS)

The HSE have issued a joint statement with PHASS aimed at providing clarity to employers and employees in Scotland in respect of safe working during COVID-19. In summary:

- Employers must continue to provide workers with information about risks to their health
- The HSE expect fair work principles to apply during the crisis.
- Businesses in Scotland should adhere to Scottish Government guidance on social distancing.
- Where businesses in Scotland do not enable social distancing (when it is practical to do so before personal protective measures), the HSE will consider a range of actions ranging from providing specific advice to employers through to issuing enforcement notices, including prohibition notices
