"Lifeline Support" for Businesses Confirmed

The Scottish Government announced yesterday (21st April) that grant funding for SME's in distress and newly self-employed people suffering hardship and SMEs in distress will be available in the coming days. The £100 million fund will be broken into three separate funds and of relevance to the construction sector will be the £34 million Newly Self-Employed Hardship Fund and the £45 million Pivotal Enterprise Resilience Fund.

The SME fund will be managed by the Enterprise Agencies and targeted at vulnerable SME firms who are vital to the local or national economic foundations of Scotland. Grant funding will be open for applications by the end of April, with recipients receiving funds in early May.

Scottish Government Statement on Economic Restart, 21st April

Speaking in the Scottish Parliament yesterday, Cabinet Secretary for Economy, Finance and Fair Work highlighted the work underway to develop sector guidance to give assurance and confidence as closed businesses at some point re-open and restart economic activity when the scientific and health advice supports it.

Ms Hyslop highlighted the work of the Construction Leadership Forum (of which CECA Scotland is a member) in working to address the wider issues needed to get the industry started again following lockdown and emphasised the Government's commitment to infrastructure investment, saying "Public sector spending on infrastructure accounts for around 50% of all construction activity across Scotland, so our infrastructure investment will play a vital role in how we reset, restart and recover the economy". Construction Scotland/Scottish Government Leadership Forum

CECA Scotland participated in the second meeting of the Construction Scotland/ Scottish Government Leadership Forum on 22nd April, chaired by Kevin Stewart MSP, Minister for Local Government, Housing and Planning, focused on COVID-19 Recovery Planning. The Scottish Government reported that as of 21st April, social distancing was now mandatory in the workplace in Scotland; guidance applicable to the construction industry is unlikely to change until 7th May at the earliest.

Contractors raised concerns over the length of the lockdown period and the financial stress that was being felt by the various contractors and suppliers in the supply chain and urged that the review of the construction guidance, a) provides a clearer definition on what an "essential project "is; b) provides clarity on what "resilience" means; c) defines what "capacity across the system" means and d) takes cognisance of the H&S steps that the industry has taken and broadens the definition of an "essential project". Contractors also requested that the guidance consider civil engineering "Critical National Infrastructure" where work is done outside and is machine orientated as opposed to labour focussed.

In response to Contractor concern that there was a reduction in the pipeline of work coming through from the public sector (according to the Public Contracts Scotland web site in March 2020 the number of tenders was down by 46% compared to 2019. And 59% down compared to 2018), the Minister informed the meeting that he had written to all Local Authority Chief Executives last week to remind them of the importance of continuing with existing or planned construction procurement.
