COVID-19 - CECA SCOTLAND UPDATE

Construction Restart Timescales

Following the publication of yesterday's Scottish Government Routemap Minister for Housing and Local Government Kevin Stewart MSP wrote to Construction Scotland, providing the latest position with regard to sites reopening. The letter confirms that the government will adopt the Six Step phased approach to reopening developed by the Construction Leadership Group, of which CECA Scotland is a member. From next Thursday 28th, subject to a positive review, the Scottish Government expects Steps 1 and 2, the advance preparation of non-essential sites, to begin, with subsequent phases reviewed by industry and government. We have since received many emails and phone calls from CECA members about timescales and phasing. We can confirm that the official Restart Plan for the construction sector, along with associated guidance and Site Operating Procedures, will be published by next Thursday 28th May. We will share this with CECA Scotland members as soon as it is fully signed off.

HSE Advice: Coronavirus and Air Conditioning

The HSE have issued a note advising that the risk of air conditioning spreading coronavirus is "extremely low". However, if you use a centralised ventilation system that removes and circulates air to different rooms, it is recommended that you turn off recirculation and use a fresh air supply. You do not need to adjust other types of air conditioning systems. Good ventilation is encouraged to help reduce the risk of spreading coronavirus.
