COVID-19 Phase 1 Business and Physical Distancing Guidance

The Scottish Government have today (29th May) issued Phase 1 guidance for businesses on physical distancing which you can access in full here. The updated guidance reflects the changes made as we enter phase 1 of the route map for moving out of lockdown and complements the measures outlined in yesterday's guidance, Coronavirus (COVID-19): staying at home and away from others.

The Chief Medical Officer for Scotland has advised that all non-essential business sectors should stay closed "unless and until we can all be clear how operations can be undertaken safely and in a way that is fully compliant with physical distancing".

Workplaces permitted to reopen in phase 1 of the route map for moving out of lockdown include:

- non-essential outdoor workplaces, with physical distancing and once relevant guidance agreed
- construction Phases 0-2 of industry restart plan can be implemented. Industry to consult government before progressing to phase 2
- workplaces resuming in later phases can undertake preparatory work on physical distancing and hygiene measures

- gradual re-opening of drive through food outlets
- garden centres and plant nurseries can reopen with physical distancing. Associated cafes should not reopen at this stage except for takeaway
- Work carried out in people's homes, for example by tradespeople carrying out repairs and maintenance, can continue, provided that the tradesperson is well and is not showing coronavirus symptoms and neither they nor any of their household are self-isolating.
