Scottish Procurement Blog: Respond Reset Restart and Recovery

A Scottish Procurement Blog has been issued (12th May) summarising recent changes introduced on procurement issues in the context of the '4 Rs' - Response, Reset, Restart and Recover, including:

- Issuing a <u>Scottish Public Procurement Policy Note</u>, highlighting the flexibility buyers have within the current rules to place contracts at this time;
- <u>Publishing guidance</u>, offering hints and tips on simplification and reminding public bodies of the range of procurement procedures available to them during the COVID-19 outbreak;
- Releasing a <u>Construction Policy Note</u>, which offers the opportunity for electronic signatures on trust documents for project bank accounts (PBAs);
- <u>Publishing guidance</u>, promoting prompt payment of invoices and highlighting options to help suppliers at risk because of the current crisis;
- Issued <u>tailored policy guidance</u> for construction procurements which also supports the <u>COVID-19</u>: <u>Guidance For Construction Sector</u>;

Work is now focused on "Restart and Recover", with work underway on **Restart**; national policy guidance, alignment of contracting plans and construction industry support and on **Recovery**; identifying and targeting emerging priorities, clarifying construction pipelines and crossfunctional/organisational interventions. UK Government Announcements

Now Open: Self-Employment Income Support Scheme

From 8am today, Wednesday 13 May 2020, self-employed individuals or members of partnerships whose business has been adversely affected by coronavirus will be able to apply for a Self-Employment Income Support Scheme (SEISS) grant, worth 80% of their average monthly trading profits, up to a maximum of £7,500), paid in a single instalment. Check if you are eligible for the scheme here.

Government to support businesses through Trade Credit Insurance guarantee

Businesses with supply chains which rely on Trade Credit Insurance and who are experiencing difficulties maintaining cover due to Coronavirus will get support from the government. The Government will temporarily guarantee business-to-business transactions currently supported by Trade Credit Insurance, ensuring the majority of insurance coverage will be maintained across the market. This will support supply chains and help businesses to trade with confidence as they can trust that they will be protected if a customer defaults on payment. HMG's Trade Credit Insurance (TCI) guarantee will cover over £171 billion business activity currently insured and the transactions between around 13000 suppliers and 650,000 buyers.
