Updated Construction Procurement Policy Notes

The Scottish Government have published (29th May) two new Construction Policy notes. Details are as follows:

CPN 3/2020: Coronavirus (COVID-19): preparations for contracting authorities to restart the procurement and management of construction contracts. This can be accessed here.

Coronavirus Job Retention Scheme (CJRS): Next Steps Confirmed

The UK Chancellor announced changes to the Job Retention Scheme on Friday 29th May. You can read the full details <u>here</u>. The changes are summarized below:

- From 1 July 2020, businesses will be given the flexibility to bring furloughed employees back to work part time. This is a month earlier than previously announced to help support people back to work. Individual firms will decide the hours and shift patterns their employees will work on their return, so that they can decide on the best approach for them and will be responsible for paying their wages while in work.
- From August 2020, the level of UK Government grant provided through the job retention scheme will be slowly tapered to reflect that people will be returning to work. That means that for June and July the Government will continue to pay 80% of people's salaries. In the following months, businesses will be asked to contribute a modest share, but

crucially, individuals will continue to receive that 80% of salary covering the time they are unable to work.

The scheme updates mean that the following will apply for the period people are furloughed:

June and July: The UK Government will pay 80% of wages up to a cap of £2,500 as well as employer National Insurance (ER NICS) and pension contributions. Employers are not required to pay anything.

August: UK Government will pay 80% of wages up to a cap of £2,500. Employers will pay ER NICs and pension contributions - for the average claim, this represents 5% of the gross employment costs the employer would have incurred had the employee not been furloughed.

September: UK Government will pay 70% of wages up to a cap of £2,190. Employers will pay ER NICs and pension contributions and 10% of wages to make up 80% total up to a cap of £2,500. For the average claim, this represents 14% of the gross employment costs the employer would have incurred had the employee not been furloughed.

October: UK Government will pay 60% of wages up to a cap of £1,875. Employers will pay ER NICs and pension contributions and 20% of wages to make up 80% total up to a cap of £2,500. For the average claim, this represents 23% of the gross employment costs the employer would have incurred had the employee not been furloughed.

Employers will be required to submit data on the usual hours an employee would be expected to work in a claim period and actual hours worked. Employees who believe they are not getting their 80% share can also report any concerns to the HMRC fraud hotline. HMRC will not hesitate to take action against those found to be abusing the scheme.

Self-Employment Support Scheme (SEISS) Extended

The UK Chancellor announced on 29^{th} May that the Government's Self-Employment Income Support Scheme will be extended; you can read full details <u>here</u>. Those eligible will now be able to claim a second and final grant in August. The grant will be worth 70 percent of their average monthly trading profits, paid out in a single instalment covering three months' worth of profits, and capped at £6,570 in total.

Construction Leadership Council Roadmap To Recovery

The Construction Leadership Council (CLC) has today (1st June) published *Roadmap to Recovery: Industry Recovery Plan for the UK Construction Sector* which you can read here. Whilst the plan states that it is the recovery plan for the UK, in reality it is a recovery plan for England and Wales only as the CLC has no practical locus in Scotland. The equivalent body in Scotland is Construction Scotland. Therefore, if you operate exclusively in Scotland, this is for your information only.

The plan has three phases - restart, reset and reinvent and focusses on a number of priorities:

- Get industry back to work wherever it is safe to do so
- Maximise employment and retain key skills
- Ensure a pipeline of future workload for all parts of the sector
- Boost productivity to secure improved value
- Transform the industry through technology & digitalisation
